30-11-2025

I am directed to refer to Ministry of Interior and Narcotics Control Letter No. 7/10/2025-Security-I-NCCIA dated 05-09-2025 on the above subject and to say that the Commission granted extension of contract period for one year w.e.f. 01-09-2024 to 31-08-2025 vide this office letter of even number dated 18-02-2025 with clear advice that no further extension in contract period will be granted unless requisition against the said posts are forwarded to FPSC within next three months. The sponsoring Ministry did not comply with this advice of the Commission.

2. The Commission has devised a uniform policy regarding grant of extension in contract appointment in its 176<sup>th</sup> Meeting dated 22-10-2025 and as per this policy, no extension after one year is allowable in case wherein recruitment rules are not framed. In instant case, the said admissible period had already been elapsed. However, the Commission has been pleased to grant extension in contract period for three (03) months w.e.f. 01-09-2025 to 30-11-2025 for the last time as a special case in respect of following 77-contract officers:-


